BY-LAW ARTICLE XXXVI Volleyball

Boys and Girls

Sect. 1: Volleyball shall be administered by the NHIAA Volleyball Committee and the rules of the National Federation will govern the sport when applicable.

Sect. 2: No volleyball school may enter more than one approved Columbus Day Tournament.

Sect. 3: Divisional Alignment

Girl's volleyball shall be aligned into three (3) divisions based upon enrollments and petitions subject to the approval of the Classification Committee. Boy's volleyball schools shall be aligned as one (1) division.
