

## BY-LAW ARTICLE XXXVII

### Volleyball

#### Boys and Girls

**Sect. 1:** Volleyball shall be administered by the NHIAA Volleyball Committee, and the rules of the National Federation will govern the sport when applicable.

**Sect. 2:** No volleyball school may enter more than one approved Columbus Day Tournament.

#### **Sect. 3: Divisional Alignment**

Girl's volleyball shall be aligned into three (3) divisions based upon enrollments and petitions subject to the approval of the Classification Committee. Boy's volleyball schools shall be aligned as one (1) division.

#### **Sect. 4: Tournament Selection**

The maximum number of teams allowed per By-Law Article IV: Classification; Sect. 10; Tournament Selection Requirements will qualify for the tournament in each division. (CM 5.2016)

**Sect. 5: Tournament Rosters**

All tournament teams/rosters will be limited to a maximum of 15 players and a maximum of five (5) non players. The five (5) non-players are inclusive of a score keeper. Rosters shall be completed via the NHIAA website. If a team is going to make the tournament, a team photo in uniform (no warm-ups and no mascots allowed) must be submitted with a photo lineup. If no photo is received a logo will be supplemented. (CM 5.2018)

**Sect. 6: Awards**

Official NHIAA championship and runner-up plaques, in addition to 20 team medals, will be awarded to the respective championship and runner-up teams in each division for boys and girls.
